Qualifications required for the posts

- (2). • An officer of the Government All Island Services Class III/II or above or similar status in the relevant field.

• At least 09 years of experience in Class III/II post

• At least 09 years of experience in the required area of specialization
3. • Having obtained a certificate of proficiency not below than the National Vocational Qualification Level 5 issued by a Technical/ Vocational Training Institute accepted by Tertiary and Vocational Education Commission for a post related to Technical Field.
with
• At least 14 years of experience in the required area of specialization

General Conditions :

- Recruitment, salary, benefits and other service conditions will be as per the provisions stipulated in Management Services Circular No. 1/2019 issued by the Ministry of Finance on 05.03.2019.
- Selections will be based on a structured interview and other circular conditions.
- All application must be filed according to the format given in this circular and send all the copies of relevant documents.
- If applying for more than one post, separate application should be submitted for each post.

02 Salary:

Salary and allowances will be paid based on the Management Service Circular no. 01/2019 issued by the Ministry of Finance.

03. Terms of Employment:

- The appointment will be on contract basis, initially for a period of one year. Extension could be considered based on the performance.
- If the applicant already holds a permanent post in the Government or Semi-Government institutions, appointment will be based on according to the release basis mentioned on para 2.3.3 in 1/2019 MSD Circular, that recommended by the appointing authority of the substantive post and the considering correct release basis.
- Candidates who have not completed the application properly and have not submitted the correct data along with the application, and those who have not fulfilled the qualifications and other requirements specified in the Management Services Circular No. 1/2019 will not be considered for appointments.
- The decision of granting appointment or not, decision of the Secretary of the Ministry according to terms of the circulars and other provisions.

04. Recommendation of the Institution Head

Applicant who already holds a permanent post in the Government or Semi-Government institutions, should be sent their applications through the Head of their respective organization and with the consent of release from the substantive post and recommendation of the release basis according to the para 2.3.3 in 1/2019 MSD Circular. (Otherwise application will be rejected.)
