or
03. Higher Diploma in the relevant field from a Technical College or higher technical education institute together with 06 years experience at Executive Level in a reputed commercial / industrial institute
or
04. Diploma in Business Management from the National Co-operative Development Institute, Polgolla together with 07 years experience at Executive Level in a reputed commercial / industrial institute
or
05. Having passed the Co-operative Development Certificate A/Level of Sri Lanka National Co-operative Board with 08 years experience at Executive Level in a reputed Commercial / Industrial Institute.

Age Limit : Only up to 60 years.

Duties and Authority assigned to the General Manager:

This Society with around 200,000 members employed in the education field in the island consists of 21 branch offices and a stall of 938. The main business activity is providing loan facilities to the members.

Direction and management of business activities of the society according to Co-operative Societies Act, Rules and Regulations, by law of the society & committee orders and public law of the country is the responsibility of the General Manager.
